During their time at River Landing, the two were active and involved residents who especially enjoyed going on the River Landing resident trips. Bill participated in creative writing competitions at River Landing and was particularly thrilled that some of his submissions proved to be award-winning contenders. Both Bill and Barbara were generous supporters of Brightspire Foundation throughout their lifetimes.

Bill passed away on July 22, 2023, at the age of 85. He is survived by his children – Peter Lemieux and wife Carol of Maryland; Nicole Lemieux of Wake Forest; and Julie Gallagher and husband Shawn of Raleigh – as well as his stepchildren, Dale Moser of Haw River and Danny Teer and wife Debra of Graham. He was also a proud grandfather and great-grandfather who cherished time spent with loved ones. In his obituary, the family encouraged memorial contributions to the River Landing Employee Scholarship Fund, a reflection of Bill's compassion and his belief in giving back to those who care for others.
