

Make A Gift from Your IRA

If you are 70½ or older you can give any amount up to \$108,000 per year directly from an IRA to a qualified charity such as ours. An IRA charitable rollover gift, also called a qualified charitable distribution (QCD), can assist Well-Spring Solutions in accomplishing our mission to exceed the needs of an evolving population of older adults through exceptional home and community-based services.

How It Works

- If you are 70½ or older, you can give any amount up to \$108,000 per year directly from your IRA to charities such as ours. For check writing purposes, please use our legal name- Adult Center for Enrichment (dba Well-Spring Solutions). The EIN number is: 56-1599072.
- Beginning in the year you turn 73, you can use your gift to satisfy all or part of your Required Minimum Distribution (RMD).
- Since the gift doesn't count as income, it can reduce your annual income level. This may help lower your Medicare premiums and decrease the amount of Social Security that is subject to tax.
- You pay no income taxes on the gift. The transfer generates neither taxable income nor a tax deduction, so you benefit even if you do not itemize your deductions.
- The transfer may be made in addition to any other charitable giving you have planned.
- The check must be mailed directly from the IRA administrator and must be made out to: Adult Center for Enrichment (dba Well-Spring Solutions). The check may be mailed to: 4100 Well Spring Drive, Greensboro, NC 27410.
